- Items may only be delivered to our company after being inspected and cleared by an authorized NETZSCH employee. This also applies for service orders. To complete this process, a copy of this form – completed in full and signed – must be sent to us in advance by e-mail or post for each returned/sent product or service order.
- We will send you a delivery slip with an RMA number for every shipment, which must be affixed to the outside of the packaging in a clearly visible way with weatherproof covering. The original of this form should be enclosed with the delivery slip. For a service order we will provide you with an estimate of service costs before receiving your authorization to perform service.
- If sending units/parts that have come into contact with media or if sending samples of medium or for a service order it is necessary under statutory regulations and our responsibility for the safety of employees and the environment that page 2 of this form is completed in full and signed by an authorized person. A maintenance visit/on-site service assignment can only success if the above properties are completely available. Suction and pressure flanges as well as cleaning and rinsing connections are to be closed with suitable, mechanically locked blind flanges to prevent unintentional leakage of liquids".
- Units/parts must be emptied and thoroughly cleaned inside and out before being sent / a maintenance visit!
- Samples of medium that has the following properties cannot be accepted or handled: explosive, radioactive, acutely toxic (categories 1 and 2), forming flammable gasses in contact with water, and biological agents in hazard groups 3 and 4. Units/parts that have come into contact with media that have the above properties are therefore only accepted or handled after evidence of decontamination has been provided.
